Association Courts COVID-19 Procedures

Winter Season 2021 (25 March 2021)

These procedures incorporate standard operating procedures for the SAUCNA Association Courts located in Josie Agius Park (Park 22) at Goodwood Road/Anzac Highway, Adelaide. These procedures are in line with the SA Government Regulations current at the date of publication and the current SAUCNA COVID-19 Management Plan approved by SA Health.

Court Access

- Primary access to the courts is from the car park located to the south of the courts. Patrons may also park on Goodwood Road or Anzac Highway (when available).
- Prior to the first match of the day entry can be made through ANY of the available gateways from the car park or from Goodwood Road/Anzac Highway.
- If arriving for the second or third matches of the day entry should be made through the Eastern gate (as marked on the attached plan). This will avoid integration of foot traffic between those arriving and those departing.
- Please do NOT arrive more than **35 minutes** before your scheduled match.
- Patrons waiting for matches at the second and third timeslots for the day must wait at the dedicated meeting points as marked on the attached plan (and as for Summer 2020/21). Your allocated game court dictates which meeting point you will wait at. QR codes are posted at these meeting points and all persons are required to check in via the QR code system unless the person does not have an appropriate device (or the system fails).
- Once the courts have been adequately cleared from the previous match a siren will be repeatedly sounded to advise that the courts are ready. Dedicated SAUCNA COVID marshals will be responsible for ensuring that the courts are cleared in a timely manner and that those arriving are not permitted on the court area until the siren has been sounded.

Match Conditions

- All matches will be centrally timed and will commence at the scheduled time in the program without exception.
- A two-minute warning bell will be sounded prior to the commencement of the first quarter.
- Teams that do not have a minimum of five (5) players present when the siren goes to commence the first quarter must forfeit the match.
- The court supervisor will determine the start time if there has been an issue clearing the courts from the previous match. This will ensure that all umpires have arrived and that all teams have had adequate time to warm up so as to prevent injury.
- The match may be stopped for injury time however no additional match time will be included. The normal injury/illness/stoppage rule will apply.

Spectators

- The number of spectators permitted is determined through the current Government Direction pursuant to the *Emergency Management Act 2004* relating to public activities. This is 1 person per 2 square metres.
- To allow for adequate vision of the matches under the current density requirements we can only permit ONE (1) spectator per player to attend each match.
- Children and siblings of players are considered spectators and therefore must be considered in the spectator numbers for each team. Where possible, please leave siblings at home with adequate

supervision. However, if siblings must accompany parents due to lack of available supervision then this should be brought to the attention of one of the COVID Marshals as a courtesy.

Team Officials

- Team officials – Coach, Team Manager, Scorer and Primary Care Person – as defined by the 2020 INF rules are not considered spectators as above. As such these people are in addition to the one (1) spectator per player rule.

CHECK-IN Requirements

- ALL people present at SAUCNA Association courts MUST check in using ONE of the following methods:
 - SAUCNA QR Code – available at multiple places on site and at the end of this document.
 - SAUCNA QR Code carried by roving Marshals.
 - Manual team COVID tracing form (copy attached)
 - Manual umpire COVID tracing form available at umpire check-in in the clubrooms.
- The manual team form MUST be submitted with scorecard even if no names appear on the form. The box at the top of the form MUST be ticked ensuring that all present had checked in either on the form or using the QR code. This is NOT negotiable and match penalties will apply if not completed correctly.
- ***** NOTE *** - The tick box is effectively a declaration that all persons present at the courts with your team have checked in using the QR code (or, if not, are listed on the manual form) AND are physically well and free of symptoms. Anyone who is unwell or symptomatic must not attend the courts.**

COVID-19 Requirements

- Teams should have sanitizer in their team bags for all players to use.
- Players not to share drink bottles. Please ensure they are labelled appropriately.
- Court-side drink bubblers will be covered to prevent use.
- Have an alternative to handshakes at the end of each game
- Teams to leave quickly after each game.
- Pole covers and chairs to wiped down after each game by the home team **using the industrial strength sanitizer provided by SAUCNA.**
- Umpires - no sharing of whistles.
- The match ball for the second half, once approved by the umpires, is to be kept by the scorers.
- All first aid kits should include sanitizer, wipes and gloves.

Any questions please ask the court supervisor or dedicated COVID-19 marshals.

We all have a responsibility to ensure that play can occur and to provide a safe playing environment for our players, officials, visitors and spectators. Thank you for your patience and co-operation.
